## Terms and Conditions:

**Exhibitor Selection:** The acceptance or rejection of exhibitors is solely up to the discretion of the selection committee. Decisions will be based on relevance to the goals of the Dungeness Kids Fair to provide a pleasant and informative event for young families.

**Payment Terms:** Payment is required with the application, and will be deposited when the exhibitor has been accepted by the committee.

**Cancellation:** Cancellation must be made in writing to the Dungeness Kids Fair by Friday, May 21, 2010 to receive a full refund. The payment is non-refundable if cancellation is made after this date.

**Indemnity:** The exhibitor accepts all risks associated with the use of the exhibit space and environs. Exhibitor agrees to hold harmless the Dungeness Baby Fair, The City of Sequim, Washington and any of its officers, agents, employees, volunteers or participants for any claims, loss, damage or injury resulting from this agreement or the exhibitors participation in this Fair.

**Booths:** A 3' by 8' table will be provided with 2-3 chairs. If other needs are requested (ie. electricity/wall space), every attempt will be made to provide them. If they can not be provided, notification will be made within 3 weeks of the event so that the exhibitor can make other arrangements.

**Exhibitor's Responsibilities:** A Washington State UBI number is required by all exhibitors. It is the exhibitor's responsibility to set-up their booth before 10am on the day of the Fair, and to clean-up no earlier than 2pm and no later than 4pm. Also, the exhibitor or its employees/volunteers must staff the booth between 10am and 2pm.

**General Rules:** There is no smoking or alcohol allowed on the premises. Also, no hazardous materials (ie. combustibles) are permitted.
